On March 31, 2017, you were mailed a Notice of Class-Action Settlement, a Change-of-Address Form, and an Employment-Information Sheet in the above-referenced lawsuit. Please be advised that you are receiving this letter—which has been authorized by the Court—to correct an inadvertent error by the Settlement Administrator on the Employment-Information Sheet.

The Employment-Information Sheet stated that Nugget Market, Inc.'s records indicate that you had been employed by Nugget Market, Inc. in California from <<StartDate>> to <<EndDate>> during the Covered Period; that you worked <<WorkWeeks>> Compensable Workweeks during the Covered Period; and that your estimated Individual Settlement Payment is approximately \$<<EstimatedAward>>. As explained in the Notice of Class-Action Settlement, your Individual Settlement Payment is to be calculated based on the number of Compensable Workweeks that you worked during the Covered Period as compared to the total Compensable Workweeks worked by all Class Members during the Covered Period. In other words, the amount of your Individual Settlement Payment depends, in part, on how many total Compensable Workweeks were worked by all Class Members during the Covered Period.

The "Covered Period" was defined under the Settlement as the period of time from February 3, 2012, through December 9, 2016. In calculating your estimated Individual Settlement Payment, the Settlement Administrator inadvertently used the time period from February 3, 2012, through March 3, 2017. Using the correct Covered Period ending on December 9, 2016, results in a revised estimated Individual Settlement Payment for you of approximately \$<<RevisedEstimatedAward>>.

Please review the enclosed updated Employment-Information Sheet carefully. Because the Covered Period is supposed to end on December 9, 2016, the number of Compensable Workweeks listed on the updated Employment-Information Sheet may be different from the number of Compensable Workweeks listed on the original Employment-Information Sheet. If you have any questions, contact the Settlement Administrator toll-free at (888) 398-8208, Monday through Friday, between 8:00 a.m. and 7:00 p.m. Central Time.
